Consideration of the bids received and the award of contract or other action may be made by the Board of Directors of the Des Moines Independent Community School District upon the proposals received in accordance with the law and the drawings and specifications at its meeting to be held January 22, 2013 at the District's Board Room located at 1800 Grand Avenue, Des Moines, Iowa 50309 or at any other published and/or posted location of the Board meeting.

The Board of Directors may make the award to the lowest responsive, responsible bidder meeting specifications. The right is reserved to reject any or all bids, or any part thereof, and to waive informalities, and to enter into such contract or contracts as shall be deemed in the best interests of the Des Moines Independent Community School District.

If the Board of Directors does award the project the contractor shall submit Signed Contracts, Certificates of Insurance by January 23, 2012. Board of Directors anticipates signing contracts February 5, 2012. The contractor shall then provide and all required Performance and Payment Bonds by February 15, 2012. By virtue of statutory authority, a preference will be given to products and provisions grown and produced within the State of Iowa, and to Iowa domestic labor.
