REQUIREMENTS:

- 1. Submit a signed quotation on your letterhead. Quotes to be submitted not later than 3:00 PM on Thursday March 28, 2013. Submit proposal to the District at 1917 Dean Avenue, Des Moines, Iowa 50316. Faxed or emailed copies of proposals are acceptable. Send proposals to the attention of Doug Ohde at douglas.ohde@dmschools.org or (FAX 515-265-8702)
- 2. Questions shall be directed in writing to douglas.ohde@dmschools.org.
- 3. It is anticipated that the successful firm will be notified on Monday April 1, 2013.
- 4. A purchase order will be provided from the Des Moines Public Schools. Exclude all State of Iowa sales taxes and use taxes from your proposal. The District will provide a tax exempt certificate with the purchase order.
- 5. The windows are currently being replaced. The sizes indicated on the blind list are approximate. Actual sizes may vary slightly. Quote shall include field verification of sizes on approximately June 3, 2013. Blinds shall be ordered and the installation shall be fully completed not later than August 2, 2013.
- 6. The quotes shall include all field verifications and complete installation. One color will be selected from the manufacturer's standard colors.
- 7. Final installations shall be complete and fully operational.
- 8. Payment will be made by Des Moines Public Schools upon completion of the full installation.
- 9. The successful firm shall submit a current acceptable insurance certificate. Bid bonds and performance / payment bonds are not required.
- 10. The successful firm shall guarantee the entire work for a period of one year from acceptance of the work.
- 11. The successful firm shall sign the attached sex offender form.

SECTION 12500 WINDOW TREATMENT

1. PART 1 GENERAL

1.1 SECTION INCLUDES

A. Horizontal metal slat louver blinds and operating hardware.

1.2 SUBMITTALS FOR REVIEW

- A. Shop Drawings: Indicate opening sizes, tolerances required, method of attachment, clearances, and operation.
- B. Product Data: Submit data indicating physical and dimensional characteristics and operating features.
- C. Samples: Submit two samples, 12 inches long, illustrating slat materials and finish, color, cord and wand types and color.

1.3 SUBMITTALS FOR INFORMATION

A. Manufacturer's Installation Instructions: Submit special procedures and perimeter conditions requiring special attention.

1.4 QUALIFICATIONS

A. Manufacturer: Company specializing in manufacturing Products specified in this section with minimum three years documented experience.

1.5 FIELD MEASUREMENTS

A. Verify field measurements prior to fabrication.

1.6 COORDINATION

A. Coordinate the Work with window installation by others.

2. PART 2 PRODUCTS

2.1 HORIZONTAL LOUVER BLINDS

- A. Manufacturers:
 - 1. Reference Manufacturer: Levolor Contract Product: Riveria Dustguard 2" Blind (Model RIV2).
 - 2. Other Acceptable Manufacturers are acceptable if they meet all the requirements including the following manufactures: a) Bali Window Treatments. b) Graber Window Treatments. c) Hunter Douglas Window Fashions.

2.2 COMPONENTS

- A. Blinds: Horizontal slat louvers hung from full-width headrail with full-width bottom rail; manual control and raising and lowering by cord with full range locking; blade angle adjustable by cords.
- B. Metal Slats: Spring tempered pre-finished aluminum; unperforated; radiused slat corners, with manufacturing burrs removed.
 - 1. Width: 2 inch.
 - 2. Thickness: 0.009 inch.
 - 3. Color: As Selected from manufacturer's standard colors
- C. Slat Support: Woven polypropylene cord, ladder configuration.
 - 1. Color: Same as slats.
- D. Headrail: Pre-finished, formed steel box, with end caps; internally fitted with hardware, pulleys, and bearings for operation; same depth as width of slats.
 - 1. Color: Same as slats.
- E. Bottom Rail: Pre-finished, formed steel with top side shaped to match slat curvature; with end caps.
 - 1. Color: Same as slats.
- F. Lift Cord: Braided polyester; per current code requirements.
 - 1. Free end weighted; cord lock.
 - 2. Color: Same as slats.
- G. Blade Adjustment Cord: Braided polyester; per current code requirements
 - 1. Free end weighted; cord lock.
 - 2. Color: Same as slats.
- H. Headrail Attachment: Ceiling or side brackets for inside or over framemounting, appropriate to mounting conditions.
- I. Accessory Hardware: Type recommended by blind manufacturer.

2.3 FABRICATION

A. Fabricate blinds to fit within openings with uniform edge clearance of 1/4 inch.

3. PART 3 EXECUTION

3.1 EXAMINATION

A. Verify that openings are ready to receive the Work.

3.2INSTALLATION

- A. Install blinds.
- B. Secure in place with concealed fasteners.
- C. Place intermediate head supports at locations recommended by blind manufacturer.

3.3 ERECTION TOLERANCES

- A. Maximum Variation of Gap at Window Opening Perimeter: 1/4 inch
- B. Maximum Offset From Level: 1/8 inch.

3.4 ADJUSTING

A. Adjust blinds for smooth operation.

3.5 CLEANING

A. Clean blind surfaces at the completion of the installation.

3.6 SCHEDULE

A. Horizontal Blind Colors: 1 color for each project, as selected from standard solid colors.
